Excellent access is provided by blacktop Flintheills Rd along the west boundary, and township gravel road along portions of the interior, southern, and eastern boundaries. 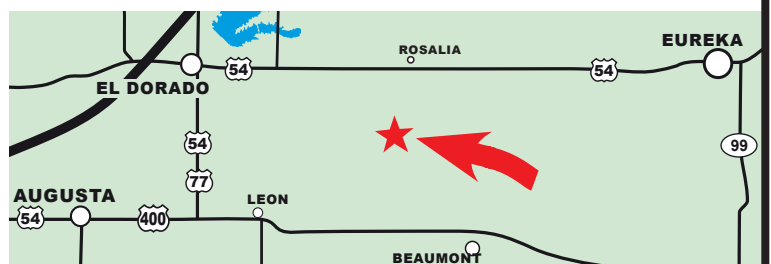
