In the identified area, the current year population is 93,106. In 2010, the Census count in the area was 86,887. The rate of change since 2010 was 0.84% annually. The five-year projection for the population in the area is 96,550 representing a change of 0.73% annually from 2018 to 2023. Currently, the population is 48.2% male and 51.8% female.

The median age in this area is 33.4, compared to U.S. median age of 38.3.

Currently, 57.1% of the 40,561 housing units in the area are owner occupied; 34.2%, renter occupied; and 8.7% are vacant. Currently, in the U.S., 56.0% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.2% are vacant. In 2010, there were 38,500 housing units in the area - 57.4% owner occupied, 33.4% renter occupied, and 9.1% vacant. The annual rate of change in housing units since 2010 is 2.34%. Median home value in the area is \$183,613, compared to a median home value of \$218,492 for the U.S. In five years, median value is projected to change by 3.88% annually to \$222,079.
